

NEW LETTER – CHANGES HAVE BEEN MADE TO WAGES & TO THE HEALTH & WELFARE CONTRIBUTION RATE

TO: All Eastern Washington and Northern Idaho Signatory Contractors

RE: June 1, 2018 Wage Increase and Fringe Benefit Allocation - Laborers' Local #238 and #348 Heavy/Highway and Building Construction Labor Agreement

Ladies and Gentlemen:

THIS LETTER IS A RE-ISSUE OF THE MAY 7, 2018 LETTER AND INCLUDES CHANGES TO WAGES AND THE HEALTH& WELFARE CONTRIBUTION RATE. Allocations have been made for the previously negotiated total package increase of \$1.13 per hour in both Pasco and Spokane effective June 1, 2018. The increase in both areas has been allocated with \$.10 \$.20 per hour to Health & Welfare, \$.10 per hour to Training and the remaining \$0.93 \$0.83 per hour to wages. Additionally, at the March 17, 2018 Dues Convention, the Union Dues were changed from \$1.38 per hour to \$1.51 per hour. The revised wage and fringe benefit rates through May 31, 2019 are as follows:

Fringe Benefit Contribution Rates: The following rates shall be effective on June 1, 2018:	
Health & Welfare	\$6.40
Pension	\$5.25
Training	\$0.70
Laborers/Employers Cooperation	
And Education Trust	\$0.10
Deductions from Wages:	
Credit Union	\$1.00
Union Dues	\$1.51
Laborers' Political League+	\$0.03

+Deduct from net wages only with written authorization from employee.

REMINDER: Under the provisions of Article 22, Public Works Projects, you must make any adjustment on the Health & Welfare contribution even though the wage rates and remaining fringe benefit contributions are frozen for the initial 24 months or duration of the project, whichever is the lesser.
