
**Re: June 1, 2022 Wage and Fringe Benefit Allocation
Laborers' Locals 238 and 348**

Ladies and Gentlemen:

Effective June 1, 2022 through May 31, 2023, there is a previously negotiated increase in the Laborers' total package for all classifications. From that increase, Thirty-five cents (\$0.35) per hour has been allocated to Health & Welfare, twenty-five cents (\$0.25) per hour allocated to Pension and the remaining increase to wages.

The wage, fringe and dues increases are effective June 1, 2022. A complete listing of the new wage and fringe benefit rates are on the back of this letter. Should you have any questions regarding any wage or benefit rate, please feel free to call the local union in your area for assistance.

REMINDER: Under the provisions of Article 22, Public Works Projects, you must make any adjustment on the Health and Welfare contributions even though the wage rates and remaining fringe benefit contributions are froze for the initial 24 months or duration of the project, whichever is the lesser.
