## **The Spinal Manipulation/Chiropractic Benefit** What's covered and what's not

Need to see the chiropractor? Make sure you understand the benefits available to you before you go. The Plan covers spinal manipulations and chiropractic care to treat neuromusculoskeletal conditions when provided by a medical doctor (M.D.), an osteopathic physician (D.O.) or a chiropractor (D.C.) and is limited to the following benefits:

- Employees or Retirees: A maximum of 24 visits per year.
- Dependents: A maximum of 12 visits per year.
- Benefits are paid at 85% after deductible, limited to \$25 per visit (in-network) and 70% after deductible, limited to \$25 per visit (out-of-network).

The Spinal Manipulation/Chiropractic benefit is not changing. However, the Board of Trustees has added language to the Plan to clarify that spinal manipulations/chiropractic care for the prevention and treatment of non-neuromusculoskeletal disorders is not a covered benefit.

The Plan's "Summary of Benefit Plan Changes" has been updated to include the following exclusion: "Spinal manipulations/Chiropractic care. Treatment of non-neuromusculoskeletal conditions is not a covered benefit." The next Plan Booklet will also include this updated language.

#### **COVID-19 update from your Health Trust**

As COVID-19 variants continue to spread throughout our communities, the risk of contracting the virus and suffering serious illness and long-term health effects is high for those not vaccinated. The Trustees urge you to protect yourself and your family and get your COVID-19 vaccination. Immunizations are highly effective at preventing serious illness from the virus and have been shown to lessen the severity in the event of a breakthrough case.

#### **Things to Know**

- Your Health Trust covers 100% of the cost of the COVID-19 vaccine
- The CDC recommends all persons over age 12 get vaccinated against the COVID-19 virus
- Pfizer vaccinations are now available for children ages 5-11
- The CDC now recommends Pfizer or Moderna vaccine booster shots (a third dose) for all adults ages 18 years and older, at least six months after their second dose
- The Flu and COVID-19 vaccines can be given at the same time
- Getting the COVID vaccination will help save your Health Plan thousands of dollars in office visits, emergency room costs, and hospital admissions

COVID-19 vaccinations are available in many convenient locations across Washington and the US. **Online:** Visit vaccines.gov, click on "COVID-19 Vaccines" and enter your zip code.

## **Personal Health Support Programs**

Your Health Trust has an arrangement with Premera Blue Cross to provide active participants and non-Medicare retirees with several personal health support programs all at no cost to you. These programs include:



**24-hour NurseLine** where medical advice is just a phone call away, 24 hours a day, 7 days a week, 365 days a year. When you call the 24-Hour NurseLine at 800-755-0011, your call will be answered quickly by a registered nurse. The nurse will not treat you or prescribe medications, but they will answer your medical questions, help you decide if you need to seek medical care and will stay on the line as long as it takes to help you make a decision. Your call is always free and confidential.



Best**Beginnings** 

**BestBeginnings Maternity Resource Program** provides pregnancy support to participants or their covered spouse, with the free BestBeginnings mobile app. Download the mobile app at Google Play or iTunes and register with the ID number found on your NWL ID card. If you register and take the Healthy Pregnancy Survey within the first 16 weeks of pregnancy, the \$500 annual deductible will be waived for the year that the baby is born.

**Personal Health Support Clinicians** are available to help you with a chronic condition, illness, or hospitalization. They are there to support you at every stage of health. Find out how to:

- Better manage a condition, such as asthma, diabetes, or heart disease
- Take care of yourself or a loved one to prevent readmission after a hospital stay
- Ask the right questions about an illness or procedure
