RE: **June 1, 2017 Increase - Heavy-Highway-Utility-Building Master Labor Agreement
 Laborers' Local #335**

Ladies and Gentlemen:

The previously negotiated total package increase of 2.5% (per Group) effective June 1, 2017 has been allocated. The total package increase has been allocated with \$.19 per hour to Pension and \$0.05 to Training with the remaining to wages. **NOTE: A Dues Convention has been scheduled for May 21, 2017. Any increase to the Dues deduction will be posted on our website, www.nwlaborers.org (Agreements & Wage Rates option on the home page) as soon as possible after the Convention and then mailed to all signatory contractors.** The revised wage and fringe benefit rates through May 31, 2018 are as follows:

Reminder: Under the provisions of Article 30, Public Works Wages, you must make any adjustment on the Health & Welfare contribution even though the wage rates and remaining fringe benefit contributions may be frozen for the initial 24 months or the duration of the project, whichever is lesser.
