Re: **June 1, 2017 Wage and Fringe Benefit Allocation
Laborers' Locals 292, 242, 440, 252 and 348**

Ladies and Gentlemen:

Effective June 1, 2017 through May 31, 2018, there is a previously negotiated increase in the Laborers' total package for all classifications and from that increase there has been a nineteen cent (\$.19) per hour allocation to Pension and a one cent (\$0.01) per hour allocation to LECET.

***NOTE: A Dues Convention has been scheduled for May 21, 2017. Any dues increase passed at that Convention will be posted on the District Council's website: www.nwlaborers.org (Agreements & Wage Rates option on the home page). Any change will also be sent via mail after that date but the website will guarantee you have the information before June 1st.**

The increases and allocations are effective June 1, 2017 and a complete listing of the new wage and fringe benefit rates are on the back of this letter. Should you have any questions regarding any wage or benefit rate, please feel free to call the local union in your area for assistance.

REMINDER: Under the provisions of Article 22, Pre-Determined Wage Rate Projects, you must make any adjustment to all fringe benefit contributions even though the wage rates are frozen for the initial 24 months or duration of the project, whichever is the lesser.
